CALL FOR THE ASSIGNMENT OF SCHOLARSHIPS FOR INTERNATIONAL DEGREES PROGRAMS

THE RECTOR

CONSIDERED the law regulating University degrees;

CONSIDERED the Statute of the Università degli Studi dell'Aquila;

CONSIDERED the D.M. Oct. 22nd 2004, n. 270;

CONSIDERED the resolution of the Academic Senate of past July the 28th, 2015 regarding Poor Countries;

CONSIDERED the possibility to use institutional funds to support students enrolled in International degrees;

ESTABLISHES

Art. 1 - Definitions:

N. 22 fellowships are made available to students enrolling in **the 1st or 2nd year** of the International Degrees delivered by **Università degli Studi dell'Aquila**. These scholarships are intended to complement grants, already available to international students within *Credit Mobility* and other *Mobility Programs for the academic year 2016/2017*, in order to enhance treatment homogeneity among them, and overall favour incoming students from poor countries, as established by the Academic Senate on July, the 28th, 2015.

The grants are assigned to students of International Degrees offered by **Università degli Studi dell'Aquila**, according to the following criteria:

1.A – Incoming students from Third Countries, selected by the partnership, enrolling in the **1st year**:

- n. 2 to students enrolling in the International Master degree in **Physics**
- n. 1 to students enrolling in the International Master degree in **Computer Science**
- n. 1 to students enrolling in the International Master degree in **Engineering for Telecommunication**
- n. 1 to students enrolling in the International Master degree in **Information and Automation Engineering**

In compliance with the *Credit Mobility* program rules, each selected student will be awarded a grant of € 850,00/month, for 3 months.

2.A – European Students, selected by the partnership, enrolling in the **1st or 2nd year**:

- n. 8 to students of the International Master degree in **Mathematics**

- n. 5 to students of the International Master degree in **Mathematical Engineering**

In compliance with the *Credit Mobility* program rules, each selected student will be awarded a grant of € 650,00/month, for 3 months.

3.A – Students from Third Countries enrolling, for the academic year 2016-17, in the **2nd year**:

- n. 1 to students of the International Master degree in **Computer Science** (5 months)
- n. 1 to students of the International Master degree in **Mathematical Engineering** (3 months)
- n. 2 to students of the International Master degree in **Mathematics** (4 months)

In compliance with the *Credit Mobility* program, each selected student will be awarded a grant of € 850,00/month.

Art. 2 - Admission Requirements

In order to be eligible for the selection, the applicants must be:

- Incoming students from Third Countries selected by the partnership to enter the above mentioned International Master Degrees, enrolling in the **1st year** for the academic year 2016/17;
- European incoming students selected by the partnership to enter the above mentioned International Master Degrees and enrolling in the **1st or 2nd year**, for the academic year 2016/17;
- Students actually enrolled in the 1st year of an International Degree Programs who fulfilled the requirements for the enrolment in the 2nd year and are coming from Poor Countries as established in the resolution of the Academic Senate of past July the 28th, 2015

Art. 3 - Applications and deadlines

Applications (Modulo A for students enrolling in the 1st year, Modulo B for students enrolling in the 2nd year), must be addressed to the Rector of the **Università degli Studi dell'Aquila** - Settore Fundraising e Progetti di Ateneo, via Giovanni Di Vincenzo 16/b – 67100 L'Aquila, and **must be received** by the office within 30 days from the publication date of this call.

Applications, that **must arrive** within the established deadline, can be submitted in one of the following ways:

- **students enrolling in the 1st year** for the academic year 2016-17,
 1. Selection certification, signed by the Chair of the study board of the degree, certifying that the student has been selected and is admitted to the degree;
 2. Evaluation of the Selection committee;
 3. Copy of identity card or passport
- **students enrolling in the 2nd year** for the academic year 2016-17,
 1. Enrolment Certificate at one of the International Degrees mentioned in this call, as obtained by the student personal page at UNIVAQ (*segreteria virtuale*);
 2. List of the passed exams with relative scores;
 3. Evaluation of the academic performance, undersigned by the Chair of the study board of the degree;
 4. Copy of identity card or passport

Art. 4 - Selection Procedure

Applications will be examined by a committee formed by the Chairs of the study boards of the International degrees: *Mathematics, Physics, Mathematical Engineering, Engineering for Telecommunication, Information and Automation Engineering, Computer Science* and chaired by Prof. Anna Tozzi. The selection is based on the following evaluation criteria:

- for selected **1st year** students:
 1. Evaluation of the Selection Committee;
 2. Lack of additional financial support from national, international or local sources;
 3. Citizenship of Poor Countries;
 4. In case of equal scores, the younger student will be preferred
- for selected **2nd year** students
 1. Weighted average, on the basis of number of credits and scores earned in the first year of the courses and on the overall rating certified by the Chair of the study board;
 2. Lack of additional financial support from national, international or local sources;
 3. Citizenship of Poor Countries;
 4. In case of equal scores, the younger student will be preferred

The Committee will also establish the criteria to re-assign grants that will still be available, due to lack of applications and/or drop-outs, redirecting funding between different grant categories of the present call.

Art. 5 - Acceptance

The selected students awarded with the mobility grant will be contacted by the Office for the International affairs in order to complete the paper work required and

Art. 6 - Personal data use
