PUBLIC SELECTION FOR A S-ESR FELLOW ON BEHALF OF THE PROJECT MODCOMPSHOCK G.A. N. 642768

HAVING REGARD TO the D.Lgs. of 30.03.2001, n. 165 and subsequent modifications and additions and in particular to the comma 6 of the art. 7 which stipulates that, for needs that cannot be coped by the staff in service, public administrations can assign to experts of particular and proved university specialization individual assignments, occasional or coordinated and ongoing autonomous employment contracts;

HAVING REGARD TO the art. 53 of the before mentioned D.Lgs. of 30.03.2001, n. 165;

HAVING REGARD TO the 7.8.1990, n. 241, and subsequent modifications, about rules on administrative procedure and right of access to administrative documents;

TAKING INTO ACCOUNT that the University has entered the Grant Agreement n. 642768 with the European Commission (hereafter "Commission") within the HORIZON Programme of the European Union on date September 9, 2015, hereinafter the "Grant Agreement" – to develop the project called "ModCompShock — Modelling and Computation of Shocks and Interfaces", for a period of 48 months starting on October 01, 2015, person in charge of scientific aspects Prof. Donatella Donatelli;

HAVING REGARD TO the fact that the EU Grant Agreement provides that the Grant is to be applied towards the carrying out of the project and research training activities identified in Annex I to the EU Grant Agreement.

HAVING REGARD TO the fact that in the EU Grant Agreement provides the positions of short term fellows, S-ESR Fellow (see article 2.2.1 of the Annex 1 PART B del G.A.) which will receive a monthly living allowance of Euro 3.318,37 (a.1) a monthly mobility allowance of Euro 600,00 (a.2) and a monthly family allowance of 250,00/ according to the family status of S-ESR (a.3)

HAVING REGARD TO the request submitted on January, 18th 2019, prot. n. 147 by prof. Donatella Donatelli to assign an employment contract for skills not available at the University of L'Aquila;





The selected researcher, in carrying his activities, is required to comply with the "Codice di comportamento dei dipendenti pubblici"- D.P.R. 16.04.2013. Violations of conduct obligations under the "Codice di comportamento dei dipendenti pubblici" is cause of the interruption of the contract and of the employment relationship.

The selected researcher will receive a gross living allowance of \in 13273,48 (before income tax and retirement pension contribution). In addition he will receive a total mobility allowance of \in 2400,00 and a family allowance (depending on family status at the date of recruitment) of \in 1000,00.

Therefore the total cost including income tax and retirement pension contribution will be € 21940,00 (salary 16673,48+ 5265,52 taxes) will be funded by the Project 04UE.MODCOMPSHOCK C.A.04.01.01.03 – Responsible Prof. Donatella Donatelli.

ART. 3 ADMISSION PREREQUISITES AND APPLICATION PROCEDURE

The candidates may apply to the selection with no limitations as to age or citizenship, in order to apply they have to fulfill the following prerequisites:

- > enjoy civil and political rights;
- > not having been convicted and not being subject to measures related to the application of preventive measures, civil decisions and administrative measures entered in the criminal records
- > be aware no to be subject to criminal proceedings;
- > to own the specific university specialization required by the admission procedure;

Moreover the candidates, within the deadline of this selection announcement, have to fulfill the following specific requirements:

- ➤ Hold a Master-level Degree or other University Degree corresponding to criteria specified in DM Ministerial Decree 509/1999, or a foreign Degree which allows the enrolment in a mathematics Phd program.
- > to be in the first four years (full-time equivalent research experience) of their research career.
- > To be enrolled in a research Phd program in mathematics

The selection procedure is **NOT OPEN** to candidates who have already been awarded by a doctoral degree.

The selection procedure is **NOT OPEN** to candidates that at the time of recruitment, have resided or carried out their main activity (work, studies, etc.) in Italy for more than 12 months in the 3 years immediately prior to the reference date.

All the submitted documents must be in pdf format.





The excluded candidates will receive an official communication with the exclusion motivations at the email address provided in the application form.

However, securities issued by Italian public administrations have to be only and exclusively self-certified, according to the Law 183/2011.

ART. 4 ASSESSMENT CRITERIA AND RANKING LIST

The candidates selection will be based on the evaluation of the submitted documentation: assessment of the candidate's CV, letters of recommendation, publications and other qualifications.

The Examination Committee, see art. 6, will create a ranking list. The Examination Committee will fix the criteria to assign the scores to the submitted documents before starting the evaluation of all the applications. The assessment criteria will be published on the department board.

In case of equal merit, the position will be conferred to the younger candidate.

ART. 5 EXCLUSIONS FROM THE SELECTION

The following issues determine the exclusion from the selection procedure:

- not complete or wrong indication of the candidate generalities (surname, name, place and date of birth) in the application form, in the case they cannot be deduced from the other submitted documents;
- application form without candidate's signature;
- omitted declaration of the admission requirements
- omitted indication for which selection procedure the candidate is applying;
- applications submitted after the application deadline;
- omitted declaration of the requirements according to art.4 l)
- missing of the copy of the title of the Degree they have obtained or of the equivalent Degree obtained in a foreign university (Diploma Supplement, Transcript);
- missing of a photocopy of the candidates identity card.
