For this purpose, pursuant to art. 46 and 47 of Presidential Decree 445/2000, aware that false declarations are punished pursuant to the criminal code and special laws on the subject, according to the provisions of art. 76 of Presidential Decree 445/2000

DECLARES:

- a. to have never received another scholarship for a Ph.D. course (art. 6, c. 2, L. 30/11/1989 n. 398);
- b. not to be the holder of another scholarship;
- c. to be the holder of a scholarship conferred by _____ (type the name of the institution) and:
 - to undertake to renounce to this scholarship by the start date of the PhD program;
 - to undertake to send a copy of the declaration of renunciation to the Ph.D. Office;
- d. to be aware that the present Ph.D. scholarship cannot be combined with other scholarships of any kind, except for those conferred from national or international Institutions useful to integrate, with a period spent abroad, the training or research activities of grant holders;
- e. to be aware that the scholarship is exempt from IRPEF, pursuant to article 4 Law n. 476/1984; also, the scholarship is subject to the social security laws, especially to article 2, paragraphs 26 and following, Law 335/1995;
- f. to be aware of the obligation to immediately communicate the possible acquisition of the status of *public employee* at any time it takes place;

- g. to be aware that the scholarship cannot be cumulated with the earnings originating from the activity as a public employee;
- h. to be aware that the request of *special live for study reasons* as a public employee (Law n. 476/984) should be related to the duration of the Ph.D. course;
- i. to be aware that if he/she intends to undertake work activities, he/she must communicate this decision to the Ph.D. Coordinator, so that the Academic Board could verify the compatibility of the employment with the productive attendance of the Ph.D. course (teaching and research activities) and, after receiving a positive opinion of the Supervisor, the Academic Board can authorize the exercise of the work activity;
- j. to be aware that he/she cannot work more than 528 hours per year, otherwise he/she will lose the scholarship (as stated in article 15, paragraph 6 of the Regulations for Ph.D. courses);
- k. to be aware that the earning of a wage higher than € 16.000,00 (gross amount per year) for working activities (which doesn't include the Ph.D. activities) implicated the loss of the scholarship;
- l. to undertake to promptly declare the circumstances referred to the points j) and k), as stated in the Regulation for Ph.D. courses;
- m. not to be subject to other mandatory forms of pensions
