THE RECTOR

HAVING REGARD TO Rectoral Decree n. 1401 - 2014 -prot. number 41467 dated 23-12-2014 and published in Gazzetta Ufficiale (Official Journal of the Italian Government) n. 2 - 09/01/15, announcing a public selection procedure at the University of L'Aquila for the recruitment of 1 full-time fixed-term contract researcher; competition sector 06/D3 - Blood diseases, oncology and rheumatology, S.D.S. MED/15 - Blood diseases;

HAVING REGARD TO art. 24, comma 2, letter C of Law 240/2010 and to art. 5 of the University's Statute concerning the recruitment of fixed-term contract researchers (R.D. N. 621/2012 as amended by R.D. 860/2013) specifying that candidates applying for selection are required to present at least 12 (twelve) publications;

HAVING REGARD TO art.1 of the selection procedure announcement, which, in reference to the number of publications required states:
"Candidates are required to present no more than 12 publications relating to the research programme not adhering to this limit will be cause for the candidate's exclusion from the selection procedure"

CONSIDERING that the aforementioned article, may lead interested applicants to believe that fewer than 12 publications are sufficient for participation,

CONSIDERING that it is necessary to avoid any form of misunderstanding in reference to the above,

HEREBY DECREES

ART. 1 - Art. 1 of the selection announcement issued through Rectoral Decree n.1401-2014 dated 23-12-2014, only in reference to the number of publications required for participation, shall be reformulated as follows:

"Candidates must present 12 publications adherent to the research programme. The candidate's Ph.D theses, in accordance with D.M. 243/2011, is to be considered one of the 12 publications. Presenting more than 12 or fewer than 12 publications shall be cause for the candidate's exclusion from the selection procedure.

ART. 2 - The 9th February 2015 application deadline has been extended to 19th February 2015.

ART. 3 - The announcement regarding this Decree shall be published in: Gazzetta Ufficiale della Repubblica Italiana - IV serie speciale - Concorsi ed Esami.
