**DECREE OF THE RECTOR NO. 336 -2015 (G.U. NO. 25 - 31.03.2015)**

A public selection procedure is being held at the University of L'Aquila to appoint 1 Full Professor in compliance with art. 18, comma 1, of Italian Law n. 240, 30 December 2010 and with the relevant University Regulations.

**Competition Sector:** 08/B3 - Structural engineering

**Scientific Disciplinary Sector:** ICAR/09 - Structural engineering

**Department of Civil, Construction-Architectural and Environmental Engineering**

**Research and teaching activities to be carried out**

The Full Professor selected for the above position will be required to carry out teaching activities, in English as well as Italian, for university courses pertaining to S.D.S. ICAR/09, including Master-level and Ph.D courses, held at the Department of Civil, Construction-Architectural and Environmental Engineering. The Professor selected will be required to carry out research relevant to the Scientific Disciplinary Sector indicated, particularly focusing on how structures react under static and dynamic conditions, including exceptional conditions such as earthquakes; the Professor selected will also be called upon to promote research activities, by obtaining public and private funding, and to organise and build up a local S.D.S. ICAR/09 research group, also through national and international collaborations. He or she will actively take part in organisational and institutional activities within the indicated Department, and the University, so as to contribute to their national and international visibility. The Professor selected will also contribute to experimental activities carried out within the Trials, Materials and Structures Laboratory and the Seismic Engineering and Geotechnics Laboratory.

**Qualifications and competence required**

a) Candidates who have obtained National Scientific Qualification in compliance with Art.16 of Italian Law 240/2010 for the indicated Competition Sector or for one of the Competition Sectors pertaining to the same Macrosector, and for the functions specified in this selection procedure, or for higher functions, as long as such higher functions have not already been officially conferred to the candidate;

b) Candidates who have obtained certification in compliance with Italian Law n. 210, 3 July,1998, for the same Full-Professor level indicated in this selection announcement, limited to its duration;

- c) Professors from other Universities already employed at Full-Professor level as requested by this selection announcement;
- d) Subjects employed abroad carrying out university research or teaching activities with positions corresponding to those specified in this selection announcement, based on the charts drawn up by the competent Ministry and attached to Italian Ministerial Decree n. 236, 2 May, 2011.

Admission requisites must be held by the candidate at the time the application is compiled and within the specified deadline.
