A public selection procedure is being held at the University of L'Aquila to appoint 1 Full Professor in compliance with art. 18, comma 1, of Italian Law no. 240, 30 December 2010 and with the relevant University Regulations.

Research activities to be carried out

Scientific research activities shall embrace General Paediatrics with particular focus on Paediatric Neurology and mainly on various epileptic syndromes and on headaches and migraines in children and adolescents.

Teaching activities to be carried out

The candidate selected shall carry out teaching activities in various study courses (bachelor and master level degree courses, graduate and specialisation schools and the two levels of university-master courses) including Ph.D Courses requiring Scientific Disciplinary Sector MED/38 in the sphere of General and Subspecialty Paediatrics.

Assistance

The candidate selected shall provide assistance at the Paediatrics and Auxology Healthcare Unit (ASL Avezzano Sulmona L'Aquila).

Qualifications required

Individuals with the following qualifications may apply:

- a) Candidates who have obtained National Scientific Qualification, in compliance with Art. 16 of Italian Law no. 240, 30 December 2010, for the indicated Competition Sector and for the functions specified in the selection procedure, or for higher functions, as long as such higher functions have not already been officially conferred to the candidate;
- b) Candidates who have obtained the required scientific qualification in compliance with Italian Law no. 210, 3rd July 1998, limited to the period of validity of the qualification obtained;
- c) Professors not employed within the University of L'Aquila who are already working elsewhere within a sector specified by the selection announcement;

d) Candidates working abroad carrying out university research or teaching activities with positions corresponding to those specified in this selection announcement, based on the equivalency lists drawn up by the competent Ministry and attached to Italian Ministerial Decree no. 236, 2^{nd} May, 2011.

Candidates are also required to possess certified specialisation in Paediatrics.

All admission requisites must be held by the candidate at the time the application is compiled and within the specified deadline.
